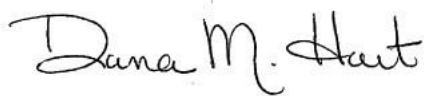

R 400.1905(4)(f)	One child care staff member had not completed Module C in the Health & Safety Trainings within 90 days of being hired.	Evelyn Bradley will assign Module C to the child care staff member. She will confirm it is completed.	06/12/2024 and 06/18/2024
R 400.1905(4)(g)	One child care staff member had not completed Module C of the Health & Safety Trainings within 90 days of being hired.	Evelyn Bradley will assign Module C to the child care staff member. She will confirm it is completed.	06/12/2024 and 06/18/2024
