Mrs. Brodberg will ensure that appropriate care and supervision of child is maintained and monitored at all time. Mr. Brodberg is no longer working at the child care.	9/6/2022
400.1913(2) Discipline; child handling.	Mr. Brodberg did not use developmentally appropriate or positive discipline, when he called the children names such as "whimp", "babies" or "liars" and yelled at them.	Mrs. Brodberg will ensure that only positive methods of discipline that encourage self control, self direction and self esteem are utilized. Mrs. Brodberg will be the only individual handling discipline.	9/16/2022

400.1913(3)(d) Discipline; child handling.	Mr. Brodberg humiliated, shamed and used derogatory remarks when calling the children names such as “whimps”, “babies” and ‘liars”.	Mrs. Brodberg will ensure no one uses derogatory remarks or inflict emotional distress on a child during child care hours. No one will humiliate, shame or threaten a child. If this happens, Mrs. Brodberg will tell this individual to stop and have said person apologize to the child. She will have a discussion with this person about what inappropriate language is and what to say instead. A conversation about the child’s behavior will also be had by Mrs. Brodberg and the parent will be notified.	9/16/2023.
