The purpose of the Interim inspection was to determine compliance with applicable licensing statutes and administrative rules for child care Group Home.

As a result of the interim inspection on 5/15/2024, licensing consultant Karen Woodman did not find any rule or law violations.


During the onsite inspection I observed small groups, transitions, and outside time. Children rotated to the different groups while I was onsite. Interactions between child care staff members and children were positive and developmentally appropriate. There was an adequate amount of age-appropriate play and learning materials. Ms. Krumm uses an alphabet-based curriculum with the children in care.
