R 400.1905(3)(a) Training.	Two child care staff members did not have training in safe sleep practice to prevent sudden	The licensee stated that the child care staff members would obtain safe sleep training.	12/02/2022

R 400.1905(9) Training.	The licensee and one child care staff member did not complete the health and safety training activity that was published on MiRegistry within six months of the notice. Neither individual completed the 2021 refresher course. As technical assistance, a private link will be sent to you so that you both can complete the 2021 training hours.	The licensee stated that she and her child care staff member would both complete the 2021 refresher course in MiRegistry.	12/02/2022
R 400.1906(1)(c) Records of a licensee; child care staff member; child care assistant.	The licensee did not have a statement signed by a licensed physician or his or her designee to attest to her physical and mental health and that of two child care staff members at the time of renewal.	The licensee stated that she would obtain the three physical evaluations and send them to the department.	12/02/2022
R 400.1919(3) Communicable disease; immunization; mental and physical health; physician attestation; tuberculosis.	One child care staff member did not provide written evidence of freedom from TB prior to caring for children. The licensee stated she did not realize it was not on the medical clearance she had obtained from the child care staff member.	The licensee stated that she would obtain the completed TB test from her child care staff member.	12/02/2022

It is expected that the corrective action plan will be implemented within the time frames as outlined in your plan.

A follow-up evaluation may be made to verify compliance. Should the corrections not be implemented in the specified time, it may be necessary to reevaluate the status of your license.
