II. Purpose of Addendum:

Mrs. Shumpert made a verbal request to change her hours of operation during the renewal inspection which was conducted on 12/2/2021. A written modification request was received on 12/5/2021. III. Methodology:

IV. Description of Findings and Conclusions:

I conducted an onsite inspection on 12/2/2022 for the purpose of renewal inspection. Mrs. Shumpert requested to change her hours of operation during this time. Mrs. Shumpert would like to accept children over the age of 12 months for overnight care. Children will utilize the home's 2 secondary bedrooms for overnight care. Both bedrooms are appropriate for use and there is a restroom adjacent to these bedrooms for children to easily access. Mrs. Shumpert has appropriate overnight sleeping equipment for children and all bedrooms are located on the main level of the home.

V. Recommendation

I recommend approval of both secondary bedrooms for use. I also recommend approval of the change in operational hours for overnight care (12:00AM – 11:59PM).
