Dear Ms. Wheaton:

This letter is a follow-up to the Department's findings regarding the interim inspection conducted at your home on 09/09/2022. The purpose of this inspection was to determine compliance with applicable licensing statutes and administrative rules for Family and Group Child Care Homes.

The violations that were found are:

R 400.1925 Comprehensive background check; fingerprinting.

- (2) An applicant or licensee shall do all of the following:
 (d) Establish and activate an account and accurately enroll each individual listed in subrule (1) in the child care background check system.

At the time of the onsite inspection, new household member Courtney Perkins was not connected to the child care home on the Federal background check system (www.michigan.gov/ccbc) as required. I was able to determine that Ms. Perkins had completed the Federal background check and was deemed "eligible", however.

R 400.1934 Heating; ventilation; lighting; radon.

- (4) A licensee shall test the child care home for the concentration of radon gas before the

initial license is issued and every 4 years thereafter at the time of license renewal.

REPEAT VIOLATION ESTABLISHED

Renewal LSR dated 07/23/2021

Corrective Action Plan dated 07/23/2021

At the time of the onsite inspection, the last radon test results on file were from 2011. Ms. Wheaton did have a Radon detector that she installed during the inspection and agreed to send me the results after 48 hours.

On September 9, 2022, you gave us an acceptable written corrective action plan.
