R 400.1907(2) Child's records.	Child information cards and "child in care statements" were not reviewed by parents and updated annually, or when information changed.	Ms. Serrano will have parents update child information cards and "child in care statements" and make sure they are updated annually.	By 2/01/2023 and ongoing every January


R 400.1910(2) Ratio of personnel to children.	There were 6 children under 18 months of age, and 2 children under 30 months of age in care with Ms. Serrano and child care staff member Ms. Risbridger.	Ms. Serrano will ensure each staff member is in ratio with 2 children under 18 months and 2 children between 18 -30 months per person.  She will have a qualified staff member in place to maintain appropriate ratios.	Immediately and ongoing  By 1/23/2023
