IV. Description of Findings and Conclusions

The terms of the original license have been modified on 11/03/2022, 10/19/2018 and 10/28/2016.

Description of Facility

The facility is a one-story home with a basement located in the city of St. Ignace. The home has an attached garage.

Rooms and levels approved for child care use:

The approved child use space located on the main floor includes: the kitchen, dining room, living room, bathroom, master bedroom and son's bedroom.

Areas not approved:

The spare bedroom on the main level of the home, the basement and attached garage are neither approved nor used for child care.

Ages of children served:

This facility serves children age birth through 12 years.

Equipment:

There is an adequate supply of developmentally appropriate equipment for the requested capacity of 14 children age birth through 12 years.

Days and hours of operation:

This facility operates Monday through Friday 7:00 am- 5:30 pm.

Previous or concurrent licenses, including children's foster care:

Ms. Bigger was previously registered for child care at 690 LeMotte Street, DF490249922, from 08/05/2002 through 05/10/2005. Ms. Bigger is not currently licensed for foster care.

Exiting information (including second floor and basement):

There are two exits from the main floor of the home. The first exit is the side door located in the kitchen and provides egress through the attached garage to the front yard. The second exit is the front door located off the living room and provides egress to the front yard.

Outdoor play area description:

The outdoor play area is located in the partially fenced back yard. Ms. Bigger indicated that it is her policy to provide direct supervision to children outdoors.

There are no water hazards. There is one dog, one cat and two guinea pigs in the home. The animals have supervised contact with the children in care.

V. Recommendation

I recommend that the spare bedroom be removed as child use space.
