Dear Ms. Landes:

This letter is a follow-up to the Department's findings regarding the interim inspection conducted at your home on 11/28/2022. The purpose of this inspection was to determine compliance with applicable licensing statutes and administrative rules for Family and Group Child Care Homes.

At the time of the onsite inspection, Ms. Landes was present with seven child care children and one child care staff member. When I arrived, the children were finishing a movie. They transitioned into free play and a coloring activity. Ms. Landes also showed them the craft they would be doing after rest time. An infant in care was in a play yard, held, and in an infant seat during the visit. The children appeared bonded to the staff and appropriate care and supervision was provided.

The violations that were found are:

R 400.1919 Communicable disease; immunization; mental and physical health; physician attestation; tuberculosis.

(3) An applicant, licensee, child care staff member, child care assistant, and a member of the household who is age 14 or older shall provide written evidence of freedom from communicable tuberculosis (TB) prior to caring for children or living in the child care home.

Ms. Landes did not ensure that all child care staff members have a negative TB test. CCSM Ms. Kendra Schmuhl did not have this required documentation.

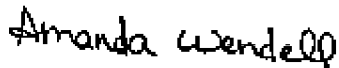
