Dear Ms. Jensen:

This letter is a follow-up to the Department's findings regarding the interim inspection conducted at your home on 08/07/2023. The purpose of this inspection was to determine compliance with applicable licensing statutes and administrative rules for Family and Group Child Care Homes.

At the time of the onsite inspection, Ms. Jensen was present with one child care staff member and eight child care children. I observed children engaged in free play and eating lunch. I also observed diapering, toileting, and hand washing. An older child also read a story to some younger children while staff were prepping lunch and changing diapers. All interactions between staff and children were positive and appropriate care and supervision was provided.

As a result of the inspection, I did not find any rule or law violations.

During the exit conference, technical assistance/consultation was provided regarding the following:

- I talked with Ms. Jensen about creating individualized emergency procedures for each child with a chronic medical condition (including allergies) or special need, and that this plan should be posted with the home's general emergency procedures.
- I reminded Ms. Jensen that a new radon test and furnace and water heater inspection are due at the time of her next renewal.
- I informed Ms. Jensen that she is no longer required to maintain a licensing notebook, as well as the required documentation she must maintain if she chooses to discontinue the use of the notebook.
