Dear Ms. Knight:

This letter is a follow-up to the Department's findings regarding the interim inspection conducted at your home on 09/21/2022. The purpose of this inspection was to determine compliance with applicable licensing statutes and administrative rules for Family and Group Child Care Homes.

During the onsite inspection, Ms. Knight had 10 children in care. Ms. Knight also had another adult assisting in the care of the children. Ms. Knight and the other caregiver engaged with the children during free play. Ms. Knight was attentive to the children's needs and provided appropriate supervision.

The violations that were found are:

R 400.1904a Child care staff member; employment requirements.

(3) Prior to contact with children, the individual shall be determined by the department to be eligible to serve as a child care staff member, pursuant to section 5n of the act, MCL 722.115n, and as required by R 400.1925.

During the onsite inspection, Ms. Knight had an individual caring for children that had not been determined by the department to be eligible to serve as a child care staff member, due to not having a comprehensive background check completed.

During the exit conference technical assistance/consultation was provided regarding the following:

- I reminded Ms. Knight that all child care staff members needed to have training on infections diseases prior to caring for children.
- I reminded Ms. Knight that all child care staff members needed to have a written, signed, and dated abuse and neglect statement at the time of hiring.
- I reminded Ms. Knight to disconnect staff members from the Child Care Background Check system that are no longer employed.
