This letter is a follow-up to the Department's findings regarding the interim inspection conducted at your home on 11/08/2021. The purpose of this inspection was to determine compliance with applicable licensing statutes and administrative rules for Family and Group Child Care Homes.

During my onsite visit, the children were napping.

The violations that were found are:

R 400.1907 **Child's records.**

(2) Records in subrule (1) of this rule must be reviewed and updated annually or when information changes.

Ten children's records were reviewed. Five child information records needed to be updated. REPEAT VIOLATION See LSR dated 11/05/2020 and CAP dated 11/05/2020.

R 400.1907 **Child's records.**

(3) Dated daily attendance records of children in care must be maintained and include the

child's first and last name and the time of arrival and departure. Electronic records may be used. If electronic records are used, they must be available to the department at the time of the inspection. If electronic attendance records are not available during an on-site inspection, the child care home is in violation of this rule.

The daily attendance had only the child's first name and last initial.
REPEAT VIOLATION see LSR dated 11/05/2020 and CAP dated 11/05/2020.
R 400.1931 Food preparation and service.

(8) Bottles used for feeding must be labeled with the child's first and last name and date, refrigerated, and served only to the child on the label.

Bottles were not labeled with the child's first and last name and date.
REPEAT VIOLATION see LSR dated 11/05/2020 and CAP dated 11/05/2020.

On 11/08/2021, you gave us an acceptable written corrective action plan.
