Approved child use space: The main level of the home is approved for child care but most of the care will be done in the basement of the home which is approved for child care. The main floor has a child care room as you enter the front door, living room, bathroom, dining room, and kitchen area. The basement has the main area, nap room, and bathroom approved for child care use.

Exiting information (including second floor and basement): The main floor has a front and back door that leads directly to the outside. There is also a door off the kitchen that exits to the garage which then leads outside. The basement has a stairway that leads to the main floor and an egress window in the nap room remotely located from the stairway that leads to the backyard.

Approved variances - No Yes Description: Mrs. Kiernan has an approved variance to R 400.1908 (1) allowing for 14 children to be cared for at one time.
