Staff records include background checks and training information. Children's records include child information cards, physical examination dates, and immunizations.

As a result of the renewal inspection on 4/15/2024, licensing consultant Tanara Abner did not find any rule or law violations. A regular license will be issued.

During my on-site inspection I observed free play, infant sleeping, and hand washing after toileting. Interaction between child care staff and children was positive and nurturing.
