Dear Ms. Heylmun:

This letter is a follow-up to the Department's findings regarding the interim inspection conducted at your home on 03/08/2022. The purpose of this inspection was to determine compliance with applicable licensing statutes and administrative rules for Family and Group Child Care Homes.

At the time of the onsite inspection, Ms. Heylmun was present with one child care staff member and ten children. Seven children were napping, one older child was playing with a colors activity, one infant was being fed, and one infant was playing in a play yard. I reminded Ms. Heylmun that if the playing infant appeared tired, all objects must be removed before she was laid down to rest. Both adults were attentive to the children's needs and were bonded with the children.

As a result of the inspection, I did not find any rule or law violations.

During the exit conference, technical assistance/consultation was provided regarding the following:

- As Ms. Heylmun could not find proof of training of safe sleep/SIDS for herself or her child care staff member, they will retake the training.
- I requested that Ms. Heylmun forward me the certificate from her safe sleep/SIDS training.
- Ms. Heylmun's daughter, Vanessa, is currently listed as a child care staff member. As she is no longer working at the child care, this role must be disconnected.
- Ms. Heylmun was in the process of having parents review and update child files.


