Dear Johlenna Guyton:

This letter is a follow-up to the Department's findings regarding the interim inspection conducted at your home on 08/30/2022. The purpose of this inspection was to determine compliance with applicable licensing statutes and administrative rules for Family and Group Child Care Homes.

The violations that were found are:

R 400.1945 Emergency; plan; drill.

(1) An applicant or licensee shall have a written emergency response plan for the care of children that must be posted in a conspicuous location within the child care home.

The plan must address the following types of emergencies:

- (a) Fire evacuation.
- (b) Tornado watches and warnings.
- (c) Serious accident or injury.
- (d) Water emergencies, if applicable.
- (e) Crisis management including, but not limited to, all of

the following:

- (i) Intruders.
- (ii) Active shooters.
- (iii) Bomb threats.
- (iv) Other man- or woman-caused events.

Updated emergency procedures with the required information of this rule were not posted. Ms. Guyton indicated the procedures were developed and updated, however, she was unable to locate them for posting while onsite.

On 08/30/2022, you gave us an acceptable written corrective action plan.


