III. DESCRIPTION OF FINDINGS & CONCLUSIONS

This renewal inspection involved a review of all applicable child care home administrative rules and statutes. Verification of compliance included direct observations of the physical environment and the program, discussions with staff,

and a review of the home's records, including staff records and children's records. Staff records include background checks, medical clearance information, and training information. Children's records include child information cards and child in care statements/receipts.

During the on-site inspection, I observed the Ms. Pringle and her child care staff member, Cynthia Allen provide direct supervision to older children in care during free play activities. I also observed Ms. Pringle and Ms. Allen being attentive to infant children in care. Both the provider and child care staff member's interaction with children in care were positive, nurturing and developmentally appropriate. All children appeared happy and well bonded to Ms. Pringle and Ms. Allen. Licensee and child care staff members provide direct supervision to children during snack time and tummy time with infant children in care. I also observed children engaged in free play activities. The provider and the child care staff members' interactions with the children were positive, nurturing and developmentally appropriately. The home was clean and safe for child care use. Required records were organized and readily available for review.

TECHNICAL ASSISTANCE: I provided technical assistance regarding the following rules:

R 400.1945 (1)(e) Emergency plans; drills:

Please ensure crisis management plan is not posted for parents to view. The plan should be easily accessible to all child care staff members. This is to ensure calm and composed thinking during emergencies and prevents poor judgments being made and possible intruders or active shooters will not have access to plan to ensure children in care's safety during a crisis.

The facility is in compliance with all applicable rules and statutes.

IV. RECOMMENDATION

I recommend issuance of a regular license to this child care group home.
