## IV. Description of Findings and Conclusions

The terms of the original license have previously been modified on 06/09/2023

The home is a ranch with a full basement and detached garage located in Freeland Michigan.

**Rooms and levels approved for child care use:** On the main floor the living room, dining room and kitchen are all approved for child care use. In the basement the entire basement except the bedroom/playroom located next to the stairs are approved for child use.

**Areas not approved:** The main floor bedrooms are not approved for child care use. In the basement, the bedroom/playroom located next to the stairs is not approved for child care use.

**Ages of children served:** Ms. Bright will provide child care for children ages birth through 12 years.

**Equipment:** There is an adequate supply of age-appropriate equipment, both indoor and outdoor.

**Days and hours of operation:** Child care will be provided Monday through Friday from 6:30 a.m. to 5:30 p.m.


**Previous or concurrent licenses, including children's foster care:** Ms. Bright had previous child care family home licenses DF730092474 and DF730260166. She has not been licensed for foster care.

**Exiting information (including second floor and basement):** There are four exits in the child care home. The first exit is the stairwell that leads to the basement to the side door on the main level with egress to the drive way. The second exit is a sliding door in the dining room with egress to the back deck. The third exit is in the living room on the main level with egress to the front porch. The fourth exit is the egress window in the playroom in the basement located in the large playroom that provides egress to the side yard.

**Outdoor play area description:** The outdoor play area is fenced and is located in the back yard. There are an adequate amount of outdoor toys and equipment that is age appropriate for 14 children ages birth through 12 years

**V. Recommendation**

I approve the removal of the bedrooms on the main level and the playroom/bedroom in the basement located next to the stairs.
