IV. Description of Findings and Conclusions

The terms of the license have been modified on 06/06/2022

On 05/04/2022 I completed an on-site renewal inspection at the Roberts group child care home. I observed the main room in the basement to be safe and appropriate for child use.

There are two remotely located exits from the basement of the home. The first exit is the stairs leading to the main level of the home. The second exit is a window that has been clearly identified. The window meets licensing requirements. The window exits into a window well that meets licensing requirements. On 05/27/2022 Ms. Roberts provided pictures of permanently affixed steps with a railing; these steps will be used to exit the window that sits 31 inches off the floor.

A. Description of Facility

Lynn Roberts group daycare home is located on King Street, between Meade and Sylvan, off South Michigan. The home is directly across the street from her previously licensed location. It is a blue, two-story home on a very large lot, with an attached garage and full basement. There is an above ground pool in the back yard. The first floor is the only level approved to be occupied by day care children. The supply of toys and play equipment is age-appropriate and adequate for the requested capacity of 12 children.

B. Program Description

Ms. Roberts will accept children birth to 13 years. Her hours of operation are 5 am to 10 pm, Sunday through Saturday.

Ms. Roberts has current first aid and CPR training

V. Recommendation

I recommend the main room in the basement of the home be approved as child use space.
