<b>R 400.1933(4) Water supply; sewage disposal; water temperature.</b>	At the time of the inspection the water temperature exceeded 120 degrees in the bathroom used for handwashing.	Ms. Duran turned it down during the inspection and agreed to monitor that it remains below 120 degrees Fahrenheit.	7/21/2022



Ms. Duran was provided with technical assistance on how to complete them and I emailed her a sample of how to write them on 7/21/2022.
