<b>R. 400 1931 (13) Food preparation and service.</b>	On August 10, 2022, I observed a child laying down in play yard with a beverage container.	Children will not be allowed bottles/cups taken to bed with them or walking around. Ms. Particka will ensure that this rule is followed at all times.	September 30, 2022


