

R 400.1905(2)	A child care staff member and a child care assistant shall complete not less than 5 clock hours of training each calendar year related to child development and caring for children, not including CPR, first aid, and infectious disease, including immunizations, training.
R 400.1907(2)	Records in subrule (1) of this rule must be reviewed and updated annually or when information changes.

R 400.1924(2)(b)	Handwashing after toileting or diapering for children.
