The terms of the original license have been modified on 09/12/2023.

This child care group home is located in a two-story family home between Farmington Rd. and Six Mile Rd. at 17148 Francavilla Rd. in the city of Livonia. The living room, dining room, family room, kitchen, and bedroom one were previously approved for child use space. The basement is not approved space for child care. Bedroom two has been approved for napping only.

The ages of children served are birth through 12 years. There is a variety of age-appropriate equipment. The home will operate 6:00 a.m. – 6:00 p.m., Monday through Friday. There is a front and patio door which will be used as the means of egress. The outdoor play area is located in the rear of the home, it is fenced.

There is no fire or environmental inspection needed for this child care group home.

## V. Recommendation

I recommend approval of additional bedroom on the second level for napping only.
