## **IV. Description of Findings and Conclusions**

The terms of the original license have been modified on 3/17/2023. The previous terms are listed below:

### **A. Discription of facility**

Ms. Word lives in a single family home on Waverly, near Davison and Woodward Ave in Highland Park MI

The approved use spaces are the basement and the kitchen. There is a bathroom on the main floor of the home as well as a bathroom in the basement.

The rest of the main floor is not approved for child use space.

The ages that will be served are children 6 weeks- 12 years old and she will operate seven days a week 6 a.m- 11 p.m.

The licensee has been previously licensed in other homes under license numbers DG820078024, DF820069376, DG820251537 and DG 820273104.

The main exits of the home are the front and back door. The exits from the basement are the side door at the top of the stairs and an approved egress window.

There is a large fenced in yard that is approved for outdoor play.

The new approved child use spaces are the basement, and the kitchen and den on the first floor.

**V. Recommendation**

I recommend approval for the facility to add the Den as a child use space. The home is licensed as a group home (capacity 7-12)
