IV. Description of Findings and Conclusions

The terms of the original license have been modified on 06/21/2022.

This child care group home is located in a two-story family home between Livernois and Eight Mile at 20019 Lichfield St. in the city of Detroit. The living room, den, bedroom 1 and back room are approved for child use space. The licensee understands the school age children must be supervised at all times when using the back room. The basement and upstairs are not approved space for child care.

The ages of children served are birth through 12 years. There is a variety of age-appropriate equipment. The home will operate 6:00 a.m. – 6:00 p.m., Monday through Friday. There is a front, side, and back door on the main level of the home. The outdoor play area is located on the side of the home, it is fenced. The backyard is also fenced on both sides with a swimming pool. The licensee is aware that the pool cannot be used until a 4-foot barrier is placed around it. The licensee will directly supervise children in the space during outdoor play.

There is no fire or environmental inspection needed for this child care group home.

V. Recommendation

I recommend approval of child use space in bedroom 1 and back room.
