Dear Ms. Anderson:

This letter is a follow-up to the Department's findings regarding the interim inspection conducted at your home on 08/31/2023. The purpose of this inspection was to determine compliance with applicable licensing statutes and administrative rules for Family and Group Child Care Homes.

During the onsite inspection on 08/28/2023, there were 6 children and 1 child care staff member present. Four of the children were napping and two were having free choice time. The children ate chicken tacos, fries, apple slices, and water.

The violations that were found are:

R 400.1942 Electrical service; maintenance.

(2) All electrical outlets, including outlets on multiple outlet devices, accessible to children must have safety covers or be tamper resistant outlets.

During the onsite inspection, there was an outlet in the living room that appeared to be burned out and partly coming out of the wall. The child care staff member said it would be repaired.

Due to the violations, you must send us a corrective action plan by 09/15/2023. You can use our [corrective action plan](#) form or create your own.

If you need help writing the corrective action plan, please contact me. If you do not send a corrective action plan, you may face disciplinary action. The corrective action plan must include the following:

- How compliance with each rule will be achieved.
- Who is directly responsible for implementing the corrective action for each violation.
- Specific time frames for each violation as to when the correction will be completed or implemented.
- How continuing compliance will be maintained once compliance is achieved.
- The signature of the responsible party and a date.


