- New records checks will be required to be completed if a staff member experiences a six month break in service from the child care industry
- New clearance is required at least once every five years
- Any staff member solely responsible for supervising children will be required to have completed a comprehensive background clearance
- All staff members are required to have completed at least a national fingerprint based clearance check
- Any staff member with only the national fingerprint based clearance, must be under constant and direct supervision of a staff member with a satisfactory comprehensive records check clearance
- Facilities are required to use DECAL KOALA for Criminal Records Checks, including to verify portability of an employee

Finding

591-1-1-.26(9) requires the playground to be kept clean, free from litter and free of hazards, such as but not limited to rocks, exposed tree roots and exposed sharp edges of concrete. It was determined based on consultant's observation, that the following hazards existed on the playground:

- Vegetation was growing throughout the chain link fence all around the playground.
- Tree roots were exposed on the pathway to the playground and at the back right side of the playground.
- The ground around the concrete slab was uneven with the ground causing a tripping hazard.

POI (Plan of Improvement)

The Center will spray paint the tree roots so that they are visible to the children and staff, cut out all the vegetation growing through the fence, and add mulch around the concrete slab to level out the ground around it.
