If you do not have this liability insurance, you are required to post a notice with ½ inch letters in a conspicuous location in the program, notify the parent or guardian of each child in care in writing, obtain their signature to acknowledge receipt and maintain this written acknowledgment on file at the program at all times while the child attends the program and for 12 months after the child's last date of attendance. (O.C.G.A. Section 20-1A-4)

All equipment and furniture shall be used only by the age-appropriate group of children. It was determined that on April 3, 2019, at 5:45 p.m., a two-year-old child sustained an injury to the right arm when the child went down the slide head first and on the stomach with the child's hands in front. Professional medical attention was obtained.
