- 2) Your name, title/relationship to the facility, e-mail address & up to two phone number(s) where you can be reached
- 3) Specific rule number(s) that you are refuting, along with your concerns or questions regarding the rule citation

Refutations must be submitted to Child Care Services (CCS) within 10 business days of the completion date.

Bright from the Start recommends that all licensed child care providers carry liability insurance coverage sufficient to protect its clients. If you do not have this liability insurance, you are required to post a notice with ½ inch letters in a conspicuous location in the program, notify the parent or guardian of each child in care in writing, obtain their signature to acknowledge receipt and maintain this written acknowledgment on file at the program at all times while the child attends the program and for 12 months after the child's last date of attendance. (O.C.G.A. Section 20-1A-4)

591-1-1-.28(2) prohibits smoking on the premises of the Center during the hours of operation and in any vehicle used to transport children during the hours the Center is in operation. It was determined based on two witness statements that the director has been observed smoking cigarettes on the premises. Two individuals advised that the director smokes outside in the left rear corner of the center in a small fenced in area.

POI (Plan of Improvement)

The Center will instruct Staff regarding the smoking ban and will notify anyone who may be on the Center premises that smoking is prohibited. The Center will monitor.
