Bright from the Start recommends that all licensed child care providers carry liability insurance coverage sufficient to protect its clients. If you do not have this liability insurance, you are required to post a notice with ½ inch letters in a conspicuous location in the program, notify the parent or guardian of each child in care in writing, obtain their signature to acknowledge receipt and maintain this written acknowledgment on file at the program at all times while the child attends the program and for 12 months after the child's last date of attendance. (O.C.G.A. Section 20-1A-4)

**Finding Associated with Complaint**

591-1-1-.11(2)(e) requires that Center Staff shall not isolate a child in a dark room, closet or unsupervised area. It was determined based on investigative findings that on March 23, 2017, a five-year-old child was isolated and unsupervised by being placed in a restroom as a form of discipline. It was further determined that children were placed in the restroom on multiple previous occasions as a form of discipline and on some occasions, the lights were off and the restroom door was closed.

**POI (Plan of Improvement)**

The director will take immediate action to ensure the action/conduct has ceased; train/review appropriate child guidance techniques with center staff; and have a system in place to monitor and identify inappropriate actions.
