If you do not have this liability insurance, you are required to post a notice with ½ inch letters in a conspicuous location in the program, notify the parent or guardian of each child in care in writing, obtain their signature to acknowledge receipt and maintain this written acknowledgment on file at the program at all times while the child attends the program and for 12 months after the child's last date of attendance. (O.C.G.A. Section 20-1A-4)

**Finding Associated with Complaint**

591-1-1-.25(12) requires heating and cooling equipment to be protected to prevent children from touching it. Fans, space heaters, etc. shall be positioned or installed so as to be inaccessible to the children. It was determined based on staff statements, interviews and investigation that there was sufficient evidence that was received to determine that the facility used a space heater in the A-Front 3's & 4's Classroom and the C-1L Back R-Infants & 1's Classroom to provide additional heating source in the building. Consultant observed one black space heater on the floor in the A-Front 3's & 4's Classroom accessible to children, and one gray space heater on top of the refrigerator in the C-1L Back R-Infants & 1's Classroom which poses potential hazards to children in care.
