Comments

Technical Assistance Consultant conducted an Initial TA Visit with the provider and helper. The consultant discussed with the provider and helper the current status of the family child care learning home including: Compliance and Enforcement Determination Worksheet, the History Grid, and Monitoring Visit dated November 29, 2017. Consultant also provided a copy of all documents to the provider. Consultant reviewed the previous visit and provided suggestions and resources to correct the previous citations.

Provider declined TA on this date. Consultant has a signed and dated copy of page 3 of the Technical Assistance Agreement Form. Provider stated he would contact consultant at a future date if assistance is needed.

Due to connectivity issues at the provider's FCCLH the TA Report could not be completed on site and signed.

You have the right to refute any of the citations noted in this report with which you disagree. To refute a citation(s), e-mail the following information to CCSRefutations@dec.al.ga.gov.

- 1) Facility name, license number and visit date
- 2) Your name, title/relationship to the facility, e-mail address & up to two phone number(s) where you can be reached
- 3) Specific rule number(s) that you are refuting, along with your concerns or questions regarding the rule citation

Refutations must be submitted to Child Care Services (CCS) within 10 business days of the completion date.

Bright from the Start recommends that all licensed child care providers carry liability insurance coverage sufficient to protect its clients. If you do not have this liability insurance, you are required to post a notice with ½ inch letters in a conspicuous location in the program, notify the parent or guardian of each child in care in writing, obtain their signature to acknowledge receipt and maintain this written acknowledgment on file at the program at all times while the child attends the program and for 12 months after the child's last date of attendance. (O.C.G.A. Section 20-1A-4)



Important New Deadlines:

Your program must be Quality Rated by December 31, 2020 in order to continue to receive Childcare and Parent Services (CAPS). Sign up for Quality Rated by June 30, 2018 in order to be eligible to receive a bonus package.
