**Support** - Program performance is demonstrating a need for improvement in meeting rules.

**Deficient** - Program is not demonstrating an acceptable level of performance in meeting the rules.

August 22, 2017: The purpose of this visit was to conduct an incident investigation. The investigative findings were not concluded on this day pending further investigation. The findings will be reviewed via telephone and the report will be emailed to the center.

September 12, 2017: The incident investigation was closed on this date. There was one rule violation found. A copy of the report was sent to the center.

**Advisement of Potential for Repeated Rule Violations during Pending Investigations**

The department shall conduct a thorough investigation to determine if in fact the alleged rule violation(s) should or should not be substantiated. Please be aware that the investigation may take some time to be finalized to ensure fairness and accuracy. During this investigation period, any violations of an identical rule or rules will require the department to treat any and all substantiated rule violations identified in the investigation as repeated rule violation(s).

Further, from time to time the department discovers additional rule violations during the course of an investigation. If there are new rule violation(s), your consultant shall inform you of the violation(s) as soon as possible. However, as stated above, any violations of identical rule(s) will require the department to treat any and all additional rule violations identified in the investigation as repeated rule violations.

All rule violations found in relation to a complaint or incident investigation will be associated with the date the investigation was closed.

Bright from the Start recommends that all licensed child care providers carry liability insurance coverage sufficient to protect its clients. If you do not have this liability insurance, you are required to post a notice with ½ inch letters in a conspicuous location in the program, notify the parent or guardian of each child in care in writing, obtain their signature to acknowledge receipt and maintain this written acknowledgment on file at the program at all times while the child attends the program and for 12 months after the child's last date of attendance. (O.C.G.A. Section 20-1A-4)

**Staffing and Supervision**

**591-1-1-.32 Supervision(CR)**

**Not Met**

**Finding Associated with Complaint**

591-1-1-.32(7) requires that children be supervised at all times and that the persons supervising in the child care area be alert, able to respond promptly to the needs and actions of the children being supervised, as well as the actions of the chaperones and Students-in-Training, and provide timely attention to the children's actions and needs. During an incident investigation, it was determined that on August 15, 2017 at approximately 9:53 a.m., a one-year-old child was left unsupervised in the classroom while the class and the staff members were on the playground. Staff members were unaware that the child was missing. The child was seen, approximately 17 minutes later, by a staff member who walked past the classroom and saw the child going out of the back door to play on the fenced- in walkway.
