If you do not have this liability insurance, you are required to post a notice with ½ inch letters in a conspicuous location in the program, notify the parent or guardian of each child in care in writing, obtain their signature to acknowledge receipt and maintain this written acknowledgment on file at the program at all times while the child attends the program and for 12 months after the child's last date of attendance. (O.C.G.A. Section 20-1A-4)

Finding Associated with Complaint

591-1-1-.25(13) requires that potentially hazardous equipment, materials and supplies be stored in a locked area inaccessible to children. It was determined that on January 23, 2018, at approximately 10:40 a.m., a ten-month-old child sustained an injury to her right leg when hot water from a bottle warmer fell from the cubbies and spilt on the child's leg. The child was crawling around on the floor when the power strip, that was connected to the bottle warmer, fell off the cubbies and pulled the bottle warmer down with it spilling the hot water on the child's leg. The power strip was not secured at the time of the incident.

POI (Plan of Improvement)

The Center will identify all hazardous items and keep them in a locked area inaccessible to children. The Center will inform all Staff about hazardous items and the safe storage of those items.
