It was determined based on consultant's observation, screw protrusions were observed on the surrounding fence gates and corner poles.

The Center will routinely check the fence to determine if it is in good repair and remains at least 4 feet high, and will repair any hazards. The Center will train Staff to identify and report any fence hazards and to keep the fence gates closed when not in use. The screws will be cut back two threads and capped if needed.
