However, as stated above, any violations of identical rule(s) will require the department to treat any and all additional rule violations identified in the investigation as repeated rule violations.

All rule violations found in relation to a complaint or incident investigation will be associated with the date the investigation was closed.

- New records checks will be required to be completed if a staff member experiences a six month break in service from the child care industry
- New clearance is required at least once every five years
- Any staff member solely responsible for supervising children will be required to have completed a comprehensive background clearance
- All staff members are required to have completed at least a national fingerprint based clearance check
- Any staff member with only the national fingerprint based clearance, must be under constant and direct supervision of a staff member with a satisfactory comprehensive records check clearance
- Facilities are required to use DECAL KOALA for Criminal Records Checks, including to verify portability of an employee

O.C.G.A. Section 42.1.12(i)(2) requires Bright from the Start: Georgia Department of Early Care and Learning to notify licensed child care programs on accessing and retrieving from the Georgia Bureau of Investigation's (GBI) website a list of the names and addresses of all registered sexual offenders. If you do not have this liability insurance, you are required to post a notice with ½ inch letters in a conspicuous location in the program, notify the parent or guardian of each child in care in writing, obtain their signature to acknowledge receipt and maintain this written acknowledgment on file at the program at all times while the child attends the program and for 12 months after the child's last date of attendance. (O.C.G.A. Section 20-1A-4)

**290-2-3-.08 Parental Authorization(CR)**

**Not Met**

**Finding Associated with Complaint**

290-2-3-.08(7) requires the Home to maintain Parental agreements for transportation and for field trips, swimming or other activities away from the Home in each Child's record. It was determined based on investigative findings that the home did not maintain parental agreement for transportation to and from vacation bible school.

**POI (Plan of Improvement)**

The Home will obtain written parental authorization, as required, before taking Children away from the Home. The Home will also review records; determine if all required information is completed; obtain any missing information; and have a plan to maintain complete records/forms for each Child as they enroll or as changes occur.

**Safety and Discipline**

**290-2-3-.11 Transportation(CR)**

**Not Met**

**Finding Associated with Complaint**

290-2-3-.11(2)(m) requires written authorization for the Child to receive emergency medical treatment when the Parent is not available, shall be maintained in the vehicle. It was determined based on investigative findings that the provider did not carry emergency medical information on the vehicle as required while transporting a child in care to and from vacation bible school.

**POI (Plan of Improvement)**

The Home Provider will obtain copies of parental authorizations and maintain them in the vehicle.
