- New records checks will be required to be completed if a staff member experiences a six month break in service from the child care industry
- New clearance is required at least once every five years
- Any staff member solely responsible for supervising children will be required to have completed a comprehensive background clearance
- All staff members are required to have completed at least a national fingerprint based clearance check
- Any staff member with only the national fingerprint based clearance, must be under constant and direct supervision of a staff member with a satisfactory comprehensive records check clearance
- Facilities are required to use DECAL KOALA for Criminal Records Checks, including to verify portability of an employee

O.C.G.A. Section 42.1.12(i)(2) requires Bright from the Start: Georgia Department of Early Care and Learning to notify licensed child care programs on accessing and retrieving from the Georgia Bureau of Investigation's (GBI) website a list of the names and addresses of all registered sexual offenders. If you do not have this liability insurance, you are required to post a notice with ½ inch letters in a conspicuous location in the program, notify the parent or guardian of each child in care in writing, obtain their signature to acknowledge receipt and maintain this written acknowledgment on file at the program at all times while the child attends the program and for 12 months after the child's last date of attendance. (O.C.G.A. Section 20-1A-4)

290-2-3-.11(2)(a) requires the Home to have a written plan for handling emergencies, including but not limited to fire, severe weather, loss of electrical power or water, and death, serious injury or loss of a child, a threatening event, or natural disaster which may occur at the Home. The Home will have in place procedures for evacuation, relocation, shelter-in-place, lock-down, communication and reunification with families, continuity of operations, accommodation of infants and toddlers, children with disabilities, and children with chronic medical conditions. No Home personnel shall impede in any way the delivery of emergency care or services to a child by licensed or certified emergency health care professionals. It was determined based on a review of records that the Home did not have an updated emergency preparedness plan for all the required items in the rule.

POI (Plan of Improvement)

The provider has a copy of the emergency preparedness plan template .The Home Provider will complete a written plan for emergencies.

An operable and appropriately sized fire extinguisher and smoke detector was observed in the home this date.

The Home appears clean and free from hazards.

The Provider stated trees located on the left side of the back yard may have structural issues that present an elevated level of risk. The Provider stated the children are not using the left side of the playground and are playing with riding toys and outside toys on the right concrete driveway. Consider having these trees inspected by a certified arborist to determine their structural integrity and associated levels of risk.

Technical Assistance

290-2-3-.13(2)(a) - Discussed with the Provider about monitoring for rust on metal bars of tricycles.

Finding

290-2-3-.13(2)(d) requires that outside play areas be protected from traffic or other hazards by fencing or other barriers at least four feet in height and approved by the Department. Fencing material shall not present a hazard to children. A fence shall be provided around swimming pools to make them inaccessible when not in use. It was determined based on observation that a section of the wooden fence on the left side of the playground was leaning. In addition a wooden slate in front of one the fence post was broken and a nail was protruding out and accessible to the children.

POI (Plan of Improvement)

The Home will repair a fence around the playground. The Home will remove the nail accessible to the children. The Home will and inspect regularly to ensure fencing material is safe and any hazards
