The Comprehensive Records Check Determination must have a Records Check Clearance Date that is no older than the preceding 12 months of the hire date; provided, however, if the Employee has had a lapse of employment from the child care industry that lasted for 180 days (6 months) or longer, a new satisfactory Comprehensive Records Check Determination is required. It was determined based on a review of records that staff #2 had a comprehensive satisfactory records check determination that expired on February 28, 2021 and was present in the home before submitting a new application on March 8, 2021 and obtaining a new comprehensive records check determination letter on March 22, 2021.

POI (Plan of Improvement)

IMMEDIATE CORRECTION - The Home will review staff files and background check expiration dates to ensure that every Employee has a valid and current satisfactory Comprehensive Records Check Determination on file prior to being present at the Home while any child is present for care or before an individual age 17 or older resides in the Home. The Comprehensive Records Check Determination must have a Records Check Clearance Date that is no older than the preceding 12 months of the hire date; provided, however, if the Employee has had a lapse of employment from the child care industry that lasted for 180 days (6 months) or longer, a new satisfactory Comprehensive Records Check Determination is required. The provider must view the A to Z Background Check video units pertaining to this records check rule and return the signed affidavit within one week from this visit date. The Home will review files and watch the videos to ensure the CRC rules are maintained.

Correction Deadline: 4/20/2021

Finding

290-2-3-.21(1)(m)3. requires that a new Comprehensive Records Check Determination be completed for the Provider and each Employee and Provisional Employee at least once every five years. It was determined based on a review of records that staff #2 had a comprehensive satisfactory records check determination that expired on February 28, 2021 and was present in the home before submitting a new application on March 8, 2021 and obtaining a new comprehensive records check determination letter on March 22, 2021.

POI (Plan of Improvement)

IMMEDIATE CORRECTION - The Home will review files and dates to ensure that each Director, Employee and Provisional Employee has a Comprehensive Records Check Determination on file that has been issued within the past five years. The provider must view the A to Z Background Check video units pertaining to this records check rule and return the signed affidavit within one week from this visit date. The Home will review background check videos and documents on file to ensure CRC rules are maintained.
