 - 3. A criminal records check for any previous state of residence completed once if:
 - a. The adult resided outside the state of Kentucky in the last five (5) years; and
 - b. No criminal records check has been completed for the adult's previous state of residence; and
 - 4. A copy of negative tuberculin results or a health professional's statement documenting that the adult is free of tuberculosis. Every two (2) years, the adult shall provide negative tuberculin results or health professional's statement documenting that the adult is free of tuberculosis.
- (b) An address check of the Sex Offender Registry conducted on behalf of the applicant for a Type II child-care center and supporting documentation shall indicate that no individual residing in the household is a registered sex offender.

155 - Staff Awake on Duty

Employee Records

300 - Background checks/left alone

- (4) A director, employee, volunteer, or any person with supervisory or disciplinary control over, or having unsupervised contact with, a child shall:
- (a) Submit to background checks described in paragraph (b) of this subsection;
 - (b) May be employed or work with a child on a probationary basis for up to ninety (90) calendar days, pending completion of a:
 - 1. Child abuse or neglect check using the central registry in accordance with 922 KAR 1:470;
 - 2. Criminal records check required by KRS 199.896(19);
 - 3. Criminal records check for any previous state of residence if the person resided outside the state of Kentucky in the last five (5) years; and
 - 4. An address check of the Sex Offender Registry; and
 - (c) Not be left alone in the presence of a child until copies of the background checks in accordance with paragraph (b) of this subsection have been received by the licensee.

Findings:

General: Based on review of documentation and interview, a caregiver hired 09/09/13, had a criminal records check dated 03/22/11 and a child abuse/neglect check dated 03/08/11 on file. Interview determined this caregiver quit work for a year; therefore, she did not have proof that her new criminal records check and child abuse/neglect were submitted upon re-employment. Also, a caregiver hired 09/01/13, and a caregiver hired 07/01/13, did not have an out of state background check from their previous state of residency.

305 - Background checks/discharged

- (5) Upon completion of background checks described in subsection (4)(b) of this section, a licensee shall discharge immediately a:
- (a) Director, employee, volunteer, or any person:

 - 4. Who has been convicted of, or has entered an Alford plea or a plea of guilty to, a drug-related felony, and five (5) years has not elapsed since the person was fully discharged from imprisonment, probation, or parole.

315 - Educational Requirements

1. High school diploma;
 2. GED or qualifying documentation from a comparable educational entity; or

Findings:

General: Based on review of documentation and interview, a caregiver hired 06/24/13, did not have education verification on file.

320 - TB Verification

- (b) Shall provide, prior to employment and every two (2) years thereafter:
1. A statement from a health professional that the individual is free of active tuberculosis; or

Findings:

General: Based on review of documentation and interview, a caregiver hired 09/09/13, had a TB skin test dated 02/24/11, and a caregiver hired 03/05/13, had a TB skin test dated 06/08/11. A caregiver hired 09/23/13, a caregiver hired 07/01/13, and a caregiver hired 06/24/13, did not have a TB documentation on file.

325 - CPR/First Aid Coverage

- (4) For a child-care center licensed for school-age children, at least one (1) person on duty and present with the children shall be currently certified by a cabinet-approved training agency in the following skills:
- (a) Adult cardiopulmonary resuscitation; and
- (b) First aid.

330 - Adequate Substitute(s)

340 - Training

- (a) Six (6) hours of cabinet-approved orientation within the first three (3) months of employment;**
- (b) Nine (9) hours of cabinet-approved early care and education training within the first year of employment, including one and one-half (1 ½) hours of pediatric abusive head trauma training; and**
- (c) Fifteen (15) hours of cabinet-approved early care and education training during each subsequent year of employment, including one and one-half (1 ½) hours of pediatric abusive head trauma training completed once every five (5) years.**

General: Based on review of documentation and interview, a caregiver hired 07/01/13 and a caregiver hired 06/24/13 did not complete orientation training.

345 - Driver Requirements

- (a) Be at least twenty one (21) years old;**
