 - 3. Criminal records check for any previous state of residence completed once if:
 - a. The adult resided outside the state of Kentucky in the last five (5) years; and
 - b. No criminal records check has been completed for the adult's previous state of residence. The check shall indicate that the adult has not been convicted of, or has not entered an Alford plea or a plea of guilty to, an offense under a criminal statute of the United States or of another state similar to an offense specified in subparagraph 1 of this paragraph; and
 - 4. Copy of negative tuberculin results or a health professional's statement documenting that the adult is free of tuberculosis. Every two (2) years, the adult shall provide negative tuberculin results or health professional's statement documenting that the adult is free of tuberculosis.
- (b) An address check of the Sex Offender Registry conducted on behalf of the applicant for a Type II child-care center and supporting documentation shall indicate that no individual residing in the household is a registered sex offender.

155 - Staff Awake on Duty

(1) Effective with the adoption of this administrative regulation, a director shall:

(l) Provide for the health, safety, and comfort of each child;

Findings:

General: Based on Observation, the director failed to provide for the health, safety, and comfort of each child. Observation of the Pre-School Room revealed that ten (10) children were seated at tables while the staff member stood at the front of the class teaching a lesson. Continued observation revealed a male child with an enrollment date of 11/1/11 and a male child with an enrollment date of 3/14/12 were seated next to one another. Continued observation revealed the two (2) aforementioned male children were kissing each other on the lips. Continued observation revealed the staff member instructed the two (2) children to stop. Continued observation revealed the two (2) children repeatedly kissed on the lips and the staff member instructed the two (2) children to stop. Further observation revealed the child with the enrollment date of 11/1/11 was attempting to kiss the child with the enrollment date of 3/4/12 again, but the child pulled his head away. Further observation revealed the two (2) children were not separated at any point during this incident and the staff member failed to intervene to discontinue the inappropriate behavior between the two (2) children.

270 - Parent Notification

(m) Notify the parent immediately of an accident or incident requiring medical treatment of a child;

275 - Caregiver Alone

(1) Effective with the adoption of this administrative regulation, a director shall:

(n) Assume that a person acting as a caregiver of a child in care shall not be left alone with a child, if the licensee has not received the results of the background checks as described in Section 3(1)(e)6 of this administrative regulation;

280 - Altered/Falsified Records

(1) Effective with the adoption of this administrative regulation, a director shall:

(o) Assure each mandatory record specified in Section 3 of this administrative regulation has not been altered or falsified;

285 - Parental/Family Involvement Activity

922 KAR 2:110. Section 4. Director Requirements and Responsibilities.

(1) Effective with the adoption of this administrative regulation, a director shall:

(p) Coordinate at least one (1) annual activity involving parental or family participation.

Employee Records

300 - Background checks/left alone

In Compliance

922 KAR 2:090. Section 6. License Issuance.

(5) An individual described in subsection (4) of this section shall:

(a) Submit to background checks described in paragraph (b) of this subsection;

(b) May be employed or work with a child on a probationary basis for up to ninety (90) calendar days, pending completion of a:

1. Child abuse or neglect check using the central registry in accordance with 922 KAR 1:470;

2. Criminal records check required by KRS 199.896(19);

3. Criminal records check for any previous state of residence if the person resided outside the state of Kentucky in the last five (5) years; and

4. An address check of the Sex Offender Registry; and

(c) Not be left alone in the presence of a child until copies of the background checks in accordance with paragraph (b) of this subsection have been received by the licensee.

305 - Background checks/discharged

In Compliance

922 KAR 2:090. Section 6. License Issuance.

(6) Upon completion of background checks described in subsection (4)(b) of this section, a licensee shall discharge immediately:

(a) An individual whose name is listed on the central registry established by 922 KAR 1:470;

(b) An individual who has been convicted of, or has entered an Alford plea or a plea of guilty to, a crime in accordance with KRS 17.165;

(c) An individual who is confirmed by an address check of the Sex Offender Registry and supporting documentation as a registered sex offender;

(d) An individual who has been convicted of, or entered an Alford plea or plea of guilty to, a drug-related felony, and five (5) years has not elapsed since the person was fully discharged from imprisonment, probation, or parole;

(e) A director who has been convicted of, or entered an Alford plea or a plea of guilty to, a felony offense involving fraud, embezzlement, theft, or forgery; and

(f) An individual who has been convicted of, or has entered an Alford plea or a plea of guilty to, an offense under a criminal statute of the United States or of another state similar to an offense specified in this subsection.

(7) An individual who has been convicted of, or entered an Alford plea or a plea of guilty to, a nonviolent felony or misdemeanor not specified in this section shall be handled on a case-by-case basis by the licensee with consideration given to the:

(a) Nature of the offense;

(b) Length of time that has elapsed since the event; and

(c) Individual's life experiences after conviction, Alford plea, or guilty plea.

310 - Personnel File

 6. For a director, employee, volunteer, or any person with supervisory or disciplinary control over, or having unsupervised contact with, a child in care, the results of a:
 - a. Child abuse or neglect check using the central registry in accordance with 922 KAR 1:470;
 - b. Criminal records check required by KRS 199.896(19);
 - c. Criminal records check from any previous state of residence completed once if:
 - (i) The individual resided outside the state of Kentucky in the last five (5) years; and
 - (ii) No criminal records check has been completed for the individual's previous state of residence; and
 - d. An address check of the Sex Offender Registry;

315 - Educational Requirements

In Compliance

1. High school diploma;

320 - TB Verification

- (b) Shall provide, prior to employment and every two (2) years thereafter:
1. A statement from a health professional that the individual is free of active tuberculosis; or
 2. A copy of negative tuberculin results.

Findings:

General: Based on Review of Documentation, the center failed to maintain a statement from a health professional that the individual is free of active tuberculosis or a copy of negative tuberculin results for all staff members. Review of a staff member's file with the hire date of 4/10/13 revealed the staff member's copy of negative tuberculin results expired on 11/2/14. No statement from a health professional or additional copy of negative tuberculin results was presented for review.

325 - CPR/First Aid Coverage

In Compliance

922 KAR 2:110. Section 5. Staff Requirements.

- (3) For a child-care center licensed for infant, toddler, or preschool-age children, at least one (1) person on duty and present with the children shall be currently certified by a cabinet-approved training agency in the following skills:
- (a) Infant and child cardiopulmonary resuscitation; and
- (b) Infant and child first aid.
- (4) For a child-care center licensed for school-age children, at least one (1) person on duty and present with the children shall be currently certified by a cabinet-approved training agency in the following skills:
- (a) Adult cardiopulmonary resuscitation; and
- (b) First aid.

330 - Adequate Substitute(s)

- (6) Child-care centers shall have available in case of need:
- (a) One (1) qualified substitute staff person for a Type II child-care center; or
- (b) Two (2) qualified substitute staff persons for a Type I child-care center.

335 - Qualified Substitute

- (7) Each qualified substitute staff person shall:
- (a) Meet the staff requirements of this administrative regulation; and
- (b) Provide the required documentation to verify compliance with this administrative regulation.

340 - Training

(14) In accordance with KRS 199.896(15) and (16), a staff person with supervisory authority over a child shall complete the following:

- (a) Six (6) hours of cabinet-approved orientation within the first three (3) months of employment;**
- (b) Nine (9) hours of cabinet-approved early care and education training within the first year of employment, including one and one-half (1 ½) hours of pediatric abusive head trauma training; and**

Findings:

General: Based on Review of Documentation, the center failed to ensure that staff members with supervisory authority over a child completed cabinet-approved training during each year of employment. Review of staff files revealed that four (4) staff members with the hire date of 4/10/13 did not complete their cabinet-approved training hours. The first staff member completed 6 of 15 hrs; the second staff member completed 14 of 15 hrs; the third staff member completed 10 of 15 hrs; and the fourth staff member completed 7.5 of 15 hrs.

Review of Documentation in the School-Age Room revealed no daily planned program of activities was posted.

Further observation revealed a bottle labeled "Carpet Cleaner", a bottle of 409 spray, and a bottle of glass cleaner were stored on the bottom shelf of an unlocked cabinet in reach of children in care. Observation of the hand sanitizer, 409 spray, and glass cleaner revealed the labels specified "Keep out of reach of children."

General: Based on Observation, Interview, and Review of Documentation, the center failed to administer medication in accordance with regulations. Observation of the One-Year-Old Room revealed a locked box stored near the diaper changing area. During interview, the staff member indicated the locked box contained diaper rash ointment for the child with the enrollment date of 12/27/13. During continued interview, the staff member revealed the parent gave the center verbal consent to use the diaper rash ointment on the child as needed. During further interview, the staff member indicated the diaper rash ointment had been used on the child on 1/5/15, 1/6/15, and 1/7/15. Review of the Medicine Log revealed the center did not obtain a written request from the child's parent to administer the diaper rash ointment.

During further interview, the staff member indicated she records each child's diaper changes on a daily log kept in the classroom. Review of the daily log for the child with the enrollment date of 12/27/13 revealed the log did not contain any information indicating diaper rash ointment had been used on the child on 1/5/15, 1/6/15, or 1/7/15. Review of the Medicine Log revealed the center did not have any written records of the administration of the diaper rash ointment for this child.

Review of the attendance records revealed that on 1/8/15 only fourteen (14) children were signed in for these rooms.

Findings:

General: Based on Observation, Review of Documentation and Interview, the center failed to maintain regulations regarding animals in the presence of children in care. Observation of the Pre-School Room revealed a small fish tank positioned on the table next to the teacher's desk. Review of the children's files revealed none of the parents had signed permission slips consenting to the fish. Interview with the owner revealed the owner was not aware parental consent was required in order to have the fish in the classroom.

1185 - Prohibited Animals
