- 4. An address check of the Sex Offender Registry; and
- (c) Not be left alone in the presence of a child until copies of the background checks in accordance with paragraph (b) of this subsection have been received by the licensee.

305 - Background checks/discharged

Findings:

General: Based on Observation, and interview, the surveyor found that the daily plan of activities was not posted in either classroom at the time of the inspection.

Furthermore, the following items were found accessible in the restroom located across the hall from the two (2)/ three (3) year old classroom: One gallon jug of H2 Orange 2 Concentrate, a can of Summer fresh (on top of the paper towel dispenser) within reach of a child, a ziplock bag of screws and a roll of black trash bags (on top of a paper towel dispenser) within reach of a child.
