For a school-age child, within scope of vision or range of voice;</p>	
<p>Findings:</p> <p>General: Based on Interview, it was found that on 01/24/2017 a staff person in the preschool classroom failed to properly supervise two (2) children in her care. Two (2) children of the opposite sex were found to have gone to the restroom together and touched private parts (penis and vagina). In an interview with the staff, she stated that the male child asked to go to the restroom while she was going over the lesson with the rest of the class. The staff stated that she did not know that the female child had snuck away from the group going into the restroom with the male child. The staff stated that when she noticed the children coming out of the restroom, she asked them if they had looked at each other's bottoms and stated that both children said "yes." The staff person stated that she later found out that the children had actually touched their body parts together and said, "they were making a baby." The staff person stated that on a different occasion on 01/26/2017 she allowed the same female child to go to the restroom in an adjoining classroom that was empty and stated that she did not realize that a male child from her classroom left the classroom and snuck into the restroom with the female child. The staff stated that she did not observe the child until he came out of the restroom.</p>
