Findings:	
General: Based on Review of Documentation and interviews, staff/child ratios were not maintained during the week of 4/9/18 to 4/13/18. Interviews determined a staff hired 3/16/15, supervised twenty-two (22), four-year-old children from 7:00 am to 8:00 am on 4/9/18 and 4/10/18; twenty (20) four-year-old children, from 7:00 am to 8:00 am on 4/11/18 and at 7:30 am on 4/12/18, and supervised sixteen (16) four-year-old children, from 7:00 am to 8:00 am on 4/13/18.
