(1) Effective with the adoption of this administrative regulation, a director shall: (l) Provide for the health, safety, and comfort of each child;</p> <p>Findings: General: Based on review of documentation, interview and observation, the child care center director failed to assure compliance with regulatory requirements regarding the health, safety and comfort of children in care. Review of documentation and interview revealed that a staff member was heard yelling at her kids by a parent walking through the hallways of the child care center after taking her kids to their rooms in the center. Additionally, a DRCC surveyor was in the Older Infant Room on 11/6/17 and could hear a staff member yelling at kids in the Preschool Room through the brick wall. The staff member was yelling at the kids to "lay down, close their eyes and to go to sleep." The Director revealed that she also heard the staff member yelling at her kids through the wall.</p>
