Continued observation revealed one (1) staff member supervising eight (8) school age children (Group #1) with six (6) of the children playing on large plastic and metal play structure while two (2) children played in a grassy area next to the structure. Continued observation revealed a second staff member with twelve (12) children (Group #2) playing in an area of the outdoor playground approximately 120 feet from the rear entrance of the center located behind a storage building. Further observation revealed the staff member supervising Group #1 was on the opposite side of the play structure with her back to the eight (8) children. Ongoing observation revealed the two (2) children in Group #1 playing in the grassy area ran to the opposite of a small hill out of view of the staff member.

Interview with the staff member for Group #2 revealed she was assigned thirteen (13) children to her group. Continued interview with the staff member revealed a child need to use the restroom and she had contacted a staff member inside the center via a walkie talkie that the child was being sent inside the center. Further interview revealed the staff member had allowed the child to walk from the group unsupervised to enter the building.
