(2)(b) The age of the youngest child in the group shall determine the:

- 1. Staff-to-child ratio; and
- 2. Maximum group size.

Findings:

General: Based on Observation, a caregiver hired 10/31/16, supervised fifteen (15), three (3) to five (5) year old children in the preschool room for five (5) minutes.

275 - Caregiver Alone

922 KAR 2:110. Section 4. Director Requirements and Responsibilities.

(1) Effective with the adoption of this administrative regulation, a director shall:

(n) Assure that a person acting as a caregiver of a child in care shall not be left alone with a child, if the licensee has not received the results of the background checks as described in Section 3(1)(e)6 of this administrative regulation;

Findings:

General: Based on Review of Documentation, observation and interview, a caregiver hired 11/28/16, supervised five (5) infants in the nursery from 12:30 p.m. to 1:00 p.m. This caregiver did not have a child abuse/neglect check and a criminal records check on file.

922 KAR 2:090. Section 6. License Issuance.

(5) An individual described in subsection (4) of this section shall:

(a) Submit to background checks described in paragraph (b) of this subsection;

(b) May be employed or work with a child on a probationary basis for up to ninety (90) calendar days, pending completion of a:

- 1. Child abuse or neglect check using the central registry in accordance with 922 KAR 1:470;
- 2. Criminal records check required by KRS 199.896(19);
- 3. Criminal records check for any previous state of residence if the person resided outside the state of Kentucky in the last five (5) years; and
- 4. An address check of the Sex Offender Registry; and

(c) Not be left alone in the presence of a child until copies of the background checks in accordance with paragraph (b) of this subsection have been received by the licensee.

Findings:

General: Based on Review of Documentation, a caregiver hired 11/28/16, did not have proof a criminal records check and a child abuse/neglect check were submitted. This caregiver was observed providing care for five (5) infants in the nursery. Interview determined this caregiver supervised the infants from 12:30 p.m. to 1:00 p.m.

(15) A child-care center shall serve:

- (a) 1. Breakfast; or
- 2. A mid-morning snack;
- (b) 1. Lunch; or
- 2. A mid-afternoon snack; and
- (c) If appropriate, dinner.

Findings:

General: Based on Review of Documentation, a review of the nursery sheet determined a child was feed at 10:10 a.m. and 2:00 p.m. on 11/14/16, which was a four (4) hour time span between meals.

(1) A child-care center shall maintain:

(a) A current immunization certificate for each child in care within thirty (30) days of the child's enrollment, unless an attending physician or the child's parent objects to the immunization of the child pursuant to KRS 214.036;

Findings:

General: Based on Review of Documentation, child enrolled 6/13/16, immunization certificate was valid until 9/30/16.
