| General: Based on review of documentation, a staff member hired 03/09/2020 did not have an evidence of submitted fingerprints to complete a background check. The KARES system was reviewed. It should be noted that the staff person was hired when the KARES program was not operating, therefore a criminal records and child abuse registry check were completed and on file. | |

Findings:

General: Based on observation and interview, the surveyor found 45 children in the cafeteria, ages six to eleven years old with two staff members, at 3:00 pm. The children were divided into three groups, where one group did not have a staff member present. In the interview, the surveyor found out that a substitute is on the way. Children were dismissed from school to afterschool program at 2:50 pm and the substitute arrived at 3:30 pm. Two staff members were over ratio and group size for approximately 40 minutes.

- 1. Name, address, date of birth, and date of employment;**
- 2. Proof of educational qualifications;**
- 3. Record of annual performance evaluation;**
- 4. Documentation of compliance with tuberculosis screening in accordance with Section 11(1)(b) of this administrative regulation; and**
- 5. The results of background checks conducted in accordance with 922 KAR 2:280;**

Findings:

General: Based on review of documentation, a staff member did not have a date of hire on file at the facility.

405 - TB Verification

(1) Child-care center staff:

(b) Shall provide, prior to employment and every two (2) years thereafter:

- 1. A statement from a health professional that the individual is free of active tuberculosis; or**
- 2. A copy of negative tuberculin results.**

Findings:

General: Based on review of documentation, a staff person with no hire date listed did not have a current TB test or statement from a health professional on file.

415 - CPR/First Aid Required Training

(8) Each center shall ensure that every staff member has received training on first aid and cardiopulmonary resuscitation (CPR).

Findings:

General: Based on review of documentation, a staff member with no hire date listed and a staff member hired 8/16/2018, did not have evidence of completed CPR/FA training on file at the facility.

435 - Training

922 KAR 2:090. Section 11. Staff Requirements.

(16) In accordance with KRS 199.896(15) and (16), a staff person with supervisory authority over a child shall complete the following:

- (a) Six (6) hours of cabinet-approved orientation completed within the first three (3) months of employment in a child-care program;
- (b) Nine (9) hours of cabinet-approved early care and education training within the first year of employment in a child care program, including one and one-half (1 ½) hours of cabinet-approved pediatric abusive head trauma training; and
- (c) Fifteen (15) hours of cabinet-approved early care and education training completed between July 1 and the following June 30 of each subsequent year of employment in a child care program, including one and one-half (1 ½) hours of cabinet-approved pediatric abusive head trauma training completed once every five (5) years.

(17) A staff person's compliance with training requirements of this section shall be verified through the cabinet-designated database maintained pursuant to 922 KAR 2:240.

Findings:

General: Based on review of documentation, three staff members (10/10/2016, 8/6/2018, and 3/9/2020) did not have evidence of completing 15 hours of annual early care and education training. A review of ECE-TRIS records supports the information found during the survey.

- (c) That provides experience to promote the individual child's physical, emotional, social, and intellectual growth and well-being; and
- (d) Unless the child-care center is a before- or after-school program that operates part day or less, that offers a variety of creative activities including:
 - 1. Art or music;
 - 2. Math or numbers;
 - 3. Dramatic play;
 - 4. Stories and books;
 - 5. Science or nature;
 - 6. Block building or stacking;
 - 7. Tactile or sensory activity;
 - 8. Multi-cultural exposure;
 - 9. Indoor and outdoor play in which a child makes use of both small and large muscles;
 - 10. A balance of active and quiet play, including group and individual activity;
 - 11. An opportunity for a child to:
 - a. Have some free choice of activities;
 - b. If desired, play apart from the group at times;

Findings:

General: Based on observation and review of documentation, the daily planned program of activities posted in the Cafeteria was no longer current. The posted daily planned program of activities was dated for the week of 09/27/2021-10/01/2021.
