<p>922 KAR 2:120. Section 2. Child Care Services. (3)(a) Each center shall maintain a child-care program that assures each child will be: 1. Provided with adequate supervision at all times by a qualified staff person who: a. Ensures the child is within scope of vision and range of voice; or b. For a school-age child, within scope of vision or range of voice;</p> <p>Findings: General: Based on Interview, staff hired 7/18/16 and 8/31/17, left a three-year-old female child outside on the outdoor playground. This child was left alone on the playground from 4:25 p.m. to 4:30 p.m. on 11/1/17. The two (2) responsible staff and five (5) other children on the playground walked out of the fenced play area entered the back entrance door to the building and entered the preschool room. Staff hired 7/8/16, realized the child was absent when she changed the board used to count the children present in the room. This three (3) year old child was not adequately supervised at all times.</p>

(1) Effective with the adoption of this administrative regulation, a director shall: (e) Manage the staff in their individual job descriptions; (f) Develop child-care center plans, policies, and procedures; (g) Supervise staff conduct to ensure implementation of program policies and procedures;</p> <p>Findings: General: Based on Interview and record review, staff hired 7/18/16 and 8/31/17, left a three-year-old female child alone outside on the outdoor playground at 4:30 p.m. on 11/1/17. This child was left unsupervised on the playground for three (3) to five (5) minutes while the other children and staff walked inside the classroom. The center's supervision policy stated: Staff must supervise the outdoor and indoor play areas in such a way that children's safety can be easily monitored and ensured.</p>
