<b>Findings:</b>	
<p>General: Based on observation and interview, and a review of documentation, two (2) staff hired on 8/6/15 and 6/9/97, left a four (4) month old female child, alone in the classroom for four (4) minutes on 9/24/19. Observation of the recorded video determined staff hired 7/24/17, entered classroom B and found a four (4) month old female child, in a bouncy seat, kicking and laughing. Staff hired 7/24/17, picked the child up in her bouncy seat and carried her outside to the playground. Surveyor reviewed written statements documented by staff hired 8/16/15, 6/9/97 and 7/24/17, which confirmed the infant child was left, unsupervised in classroom B for four (4) minutes.</p>
