Findings:	
<p>General: Observation of the Infant Room on 2/11/2020 from 12:07pm-12:28pm revealed three (3) staff members caring for twelve (12) children. Interview with a staff member working in the room revealed that the children ranged in age from eight-weeks-old through eleven-months-old causing the room to be over the group maximum group size for the age range of the children in care at the time of the survey.</p>
